### **New equipment provides expanded services**

Chase County Community Hospital purchased a Forced Triad Energy Platform for use in surgical procedures. This new equipment offers surgeons a wide range of options including electrosurgical cutting and coagulation and more efficient tissue fusion. This technology also provides for improved tissue-sensing and more consistent tissue and vessel fusion.

The main benefits to patients are it aids in shorter operation time and quicker recovery. The new equipment was funded through a private grant secured by the Chase County Hospital Foundation.

**C-Arm**—This new addition provides an imaging process that uses X-rays to obtain real-time moving images of the internal structures of a patient. The benefits include real time imaging that aids physicians in tracking endoscopes and catheters, identify foreign bodies and can be used to help place stents. All this can be captured dynamically and images stored electronically.

**Treadmill**—A new commercial treadmill was added to the Cardiac Rehabilitation and Physical Therapy Departments. It is used to help cardiac patients in their recovery and physical therapy patients to strengthen legs.

It is capable of monitoring heart rates and is capable of being pre-programmed for custom workouts. Funding for the treadmill was provided by donors to the Chase County Hospital Foundation.

### **Board of Trustees searches for interim-CEO**

The CCCH Board of Trustees is currently in the process of searching for an interim CEO. They have visited with several candidates and interviews will continue into January.
